- First part 'Underlines that accession to the EU must take place in accordance with Article 49 TEU, based on respect for the relevant procedures and conditional upon the fulfilment of the established criteria, in particular the Copenhagen criteria for EU membership; underlines that accession should always remain a merit-based process that requires the adoption and implementation of the relevant reforms by the Western Balkan countries, Ukraine, the Republic of Moldova and Georgia, in particular in the areas of democracy, the rule of law, human rights, fundamental freedoms, respect for and protection of minorities, the market economy and implementation of the EU acquis; welcomes the efforts by many candidate and potential countries authorities' to advance the reform agenda and encourages them to redouble their efforts in order to progress towards EU membership, in line with the Commission recommendations; expects concrete progress in the coming period in the EU-facilitated Belgrade-Pristina Dialogue and expects the parties to deliver on their commitments; reiterates its calls on the Commission and the Council to lift the restrictive measures taken against Kosovo;'
- Second part 'emphasises that the use of unresolved bilateral and regional disputes to block candidate countries' accession processes must be avoided during the EU enlargement process; calls upon the Commission to propose a mechanism which will ensure that the resolution and arbitration of these disputes is separate from the candidates' accession to the EU; notes that the Member States' use of bilateral issues for their own benefit is contrary to the spirit of the EU Treaties; in this context, deplores the resurgence of one-sided historical demands by some Member States, which hinders the EU path of certain candidate countries and considerably undermines the credibility of the EU;'

- First part 'Emphasises the need for internal EU reforms in parallel with the process of enlargement, to enhance the Union's capacity to integrate new members effectively as foreseen by the 1993 Copenhagen European Council conclusions, to ensure that the enlargement process contributes positively to the overall cohesion and stability of the Union'
- Second part 'and to enhance the EU's capacity to act by reforming decision-making,'
- Third part 'including through the introduction of qualified majority voting, including for foreign and security policy decisions and in areas relevant to the accession process;'

First part 'Recognises that two regulations already constitute an exception to the territorial exclusivity of the audiovisual sector, namely the Portability Regulation, which provides for the portability of a subscription to an online content service across Member States, and Directive (EU) 2019/789 on the exercise of copyright and related rights applicable to certain online transmissions, which provides for access to news and current affairs programmes and fully financed own productions by broadcasting organisations across the European Union; believes that, in particular, the Portability Regulation delivered substantial benefits to consumers who expect to receive continued access to their services when they are temporarily located in another Member State; notes the Commission's Report on the application of the Portability Regulation from June 2022, which explains that the legal fiction set out in Article 4 of that Regulation has allowed the territorial constraints of copyright and related rights to be overcome'

Second part 'without any significant revenue loss for right holders; asks the Commission to assess the possibility of applying a similar approach in the Geo-blocking Regulation;'

§ 24

First part 'In this context, calls on the Commission to propose tangible solutions that will allow consumers, in particular citizens living in cross-border regions or belonging to linguistic minorities, legal access to varying cross-catalogue content across borders; recalls the obligation for the Commission to report on the evaluation of the Geo-blocking Regulation'

Second part 'and recommends accompanying it with a comprehensive revision of the Geo-blocking Regulation by 2025 the latest, with a particular focus on the inclusion of audiovisual services in the scope of the Regulation'

Third part 'while acknowledging the need for further assessment of the potential impact on the overall dynamics of the audiovisual sector ensuring sustainable business models for economic operators; recommends that owing to its complexity as a result of factors such as the diversity of content, providers, business models, consumers' preferences, licensing models and complex value chains, the Commission should consider a gradual approach, targeting specific type and distribution models of the audiovisual sector one-by-one, and gather additional evidence before further steps are taken;'

Fourth part 'while assuring realistic timeframes for any potential changes that will allow providers of audiovisual services to adapt their business models properly to the new rules and ensure the preservation of cultural diversity and quality of content;'

§ 25

First part 'Recalls the importance of supporting a policy of European co-productions, reflecting the richness and diversity of European culture, and the importance of strengthening the international distribution of works;'

Second part 'calls on the Commission to fund a selection of emblematic European films to be made available online in all countries and languages via the Creative Europe MEDIA programme;'

Third part 'calls on the Commission to fund more projects for dubbing and subtitling audiovisual works through the MEDIA programme, and to work towards improving access to cinematic heritage works;'

Fourth part 'is concerned that geo-blocking also occurs in the case of audiovisual productions funded or co-funded by the EU MEDIA programme and is of the opinion that whenever EU funds are involved in the financing of audiovisual content, no EU citizen should be deprived of access to it;'
