G. whereas Saudi Arabia has for many years been among the countries carrying out the highest number of executions in the world, ***after China, Iran, Egypt and Iraq***; whereas since January 2015 there have been more than 800 executions, a large number of these for non-violent drug offences, while others were for offences described by the authorities as terrorism-related but which were peaceful; ***whereas according to statistics provided by human rights organisations, the recorded executions in Saudi Arabia dropped with 85 % to 27 executions in 2020, marking a significant downward trend compared to years before; whereas in Iran over 270 people are executed yearly; whereas China remains the leading executioner with at least 483 people executed in 2020; whereas every execution is one too many***;
