i) **EC Communication on "A long-term Vision for the EU's Rural Areas - Towards stronger, connected, resilient and prosperous rural areas by 2040" (COM(2021)0345)**

Coordinators decided to request the application of Rule 58 (joint committee procedure) to the planned AGRI INI report.

They postponed a decision on which group in REGI will nominate a rapporteur for opinion until the outcome of the Rule 58 request is known.

ii) **Amending Regulation (EU) No 1380/2013 of the European Parliament and of the Council of 11 December 2013, as regards restrictions to the access to Union waters (COM(2021)0356)**

Responsible: PECH                      Opinion: DEVE, ENVI, REGI

Coordinators agreed that REGI will draw up an opinion (2 points). They agreed provisionally, pending confirmation by Ms Donato, that the ID group will nominate the rapporteur for opinion.

### **3. Budget 2022: Update**

---

Coordinators took note of the current state of play on the Commission budget for 2022, namely:

On 24 February, coordinators decided that, to draw up an opinion in the form of a letter on the Guidelines for Budget 2022, but not to draw up an opinion on the October budget resolution. REGI Members will submit PPPAs and, on behalf of the committee, the Chair will table a set of amendments correcting any cuts in the draft budget made by Council in its first-reading position. Members wishing to table other amendments are invited to do so directly in BUDG.

On 8 June 2021, the Commission adopted the Statement of estimates 2022 and on 9 July 2021 the Draft Budget 2022 in all languages.

On 14 July 2021, the Council (Coreper) is expected to adopt its position on the draft budget.

The deadline for committees to submit amendments to BUDG on Council's first-reading position on the draft budget is 2 September.

If some Members, based on the pre-assessment feedback, wish to modify their PPPAs, they are asked to send their revised proposal, in its final form as a budgetary amendment, to the secretariat by 20 August 2021.

The secretariat will prepare and send to the Chair a final set of amendments to be tabled to BUDG (final versions of PPPAs and amendments restoring any cuts to the draft budget): they will copy these to the coordinators, for information.

### **4. Letter to EIB**

Coordinators recalled their exchange of views on 15 June with Ms Lilyana Pavlova, Vice-President of the EIB, about the orientation paper being prepared on the EIB's activities and cohesion policy in 2021-27.

They took note of the input of the GREENS and RENEW groups on three questions that Ms Pavlova had raised in the course of the discussion.

They agreed that the other political groups would send, as soon as possible, to the Chair (cc REGI secretariat mailbox) any further elements for a letter to the EIB on behalf of the Committee.

## **5. European Cross-Border Mechanism**

---

Coordinators recalled that the proposal for a Regulation COM(2018)373 2018/0198(COD), on which the EP had held its first-reading on 14 February 2019, had been discussed by the Council Working Party on Structural Measures on 10 May 2021; and that the Working Party had decided that the Council will not continue work on the proposal. They noted further that this decision had been confirmed by the Slovenian minister when he had outlined the Presidency priorities earlier in the Committee meeting.

The EPP coordinator proposed an Oral Question to the Council on this dossier, and other coordinators assented. The coordinators asked the political group advisors to prepare a possible press conference on this matter.

## **6. Public hearing with mayors of European cities**

---

Coordinators recalled their decision on 15 June to hold a hearing with governmental leaders at city level on the implementation of the CRII and CRII+ initiatives in Europe's regions.

They agreed to seek authorisation from the CCC and Bureau to hold this hearing in the course of the Committee meeting on 6 December.

They further agreed to send the names of possible speakers to the Chair (cc REGI-secretariat mailbox), who will draw up a list of speakers respecting political and geographical balance for their final approval at a later meeting.

## **7. Follow up on implementation of the CPR and other cohesion legislation**

---

The coordinators agreed that the Chair should write a letter to Commissioner Ferreira, asking for systematic provision of draft implementing acts dealing with, inter alia: allocation of resources by Member State and region; subsequent draft programming documents drawn up by Member States and regions; respect for the partnership principle (involvement of regional and local governments, as well as social partners, civil society organisations and equality

bodies in the preparation of partnership agreements and programmes), and the “Do No Significant Harm” principle.

## **8. Gender Equality Week, 25-29 October 2021**

---

Coordinators noted that, since REGI will not meet in this week, there is no possibility of incorporating a gender equality element into a committee agenda; but recalled that REGI had recently sent to plenary an INI report on “The Gender Dimension in Cohesion Policy”.

At the suggestion of the Chair, coordinators agreed that the political groups would organise a communication initiative to highlight how the Committee promoted gender equality in the areas for which it is responsible.

## **9. Any other business**

---

There were four other items of business:

- i) Responding to a request from Mr Tajani, chair of the CCC, for proposals for possible missions outside the three normal places of work in weeks 44 (3-5 November) and 51(20-24 December), coordinators decided to seek (re-)authorisation to send missions to Slovakia and Spain.
- ii) Coordinators asked the secretariat to begin work so as to permit the fullest possible REGI involvement in the legislative procedures arising from the “Fit for 55” package to be adopted by the Commission on 14 July.
- iii) Coordinators decided that, rather than appointing a single standing REGI rapporteur to follow the New European Bauhaus initiative, the groups should each nominate one of their Members to join a team of REGI NEB shadows. The groups are invited to send names to the secretariat as soon as convenient.
- iv) Coordinators held a frank exchange of views about relations between the groups in the Committee. They agreed that these should continue to be conducted in a gentlemanly manner, with courtesy and mutual respect between Members. They acknowledged that the very nature of politics includes the pursuit by actors of different, sometimes incompatible, aims; but also that, in democratic systems, such differences can be resolved in an inclusive manner by voting arrangements governed by a set of agreed rules.
