The European Parliament,

- having regard to the Treaty establishing the European Community, and in particular Article 272 thereof,
- having regard to the Treaty establishing the European Atomic Energy Community, and in particular Article 234 thereof,
- having regard to the Financial Regulation of 21 December 1977 applicable to the general budget of the European Communities, as last amended by Regulation (EC, ECSC, Euratom) No 2673/1999¹, and in particular Articles 15 and 32 thereof,
- having regard to the general budget of the European Communities for the financial year 2000, adopted on 16 December 1999²,

- having regard to preliminary draft supplementary and amending budget No 1 for the financial year 2000, submitted by the Commission (SEC(2000) 757),
- having regard to draft supplementary and amending budget No 1 for the financial year 2000, established by the Council (9257/2000 - C5-0314/2000),
- having regard to the Interinstitutional Agreement of 6 May 1999¹,
- having regard to its position of 4 May 2000 on the proposal for a Council regulation on support to bodies set up by the international community after conflicts either to take charge of the interim civilian administration of certain regions or to implement peace agreements (COM(2000) 95 C5-0118/2000 –2000/0042(CNS))²,

- A. whereas draft supplementary and amending budget No 1 for the financial year 2000 deals, on the revenue side, with the balances from the budget for the financial year 1999, with a revision concerning customs duties, VAT and GNP, as well as with the correction of the budgetary imbalance for the UK and other opting-out decisions,
- B. whereas it also introduces minor changes to the nomenclature in Subsection B1 and provides for transfers of appropriations within headings 3 and 4 of the financial perspective on the expenditure side,
- C. whereas it has undertaken to carry out redeployment in order to cover additional requirements for Kosovo in 2000,
- 1. Notes the new statement of revenue resulting from draft supplementary and amending budget No 1 for the financial year 2000;
- 2. Takes note of the amendments made to the nomenclature in Subsections B1 and B2 pursuant to the rules in force;
- 3. Decides to amend draft supplementary and amending budget No 1 for the financial year 2000:
- 4. Calls on the Council to accept all its amendments as soon as possible, given the urgency of the requirements to be financed;
- 5. Instructs its President to forward this resolution to the Council and the Commission.
