European Parliament legislative resolution of 15 September 2021 on the proposal for a regulation of the European Parliament and of the Council amending Regulation (EU) 2017/625 as regards official controls on animals and products of animal origin exported from third countries to the Union to ensure compliance with the prohibition of certain uses of antimicrobials COM(2021)0108 – C9-0094/2021 – 2021/0055(COD))

### (Ordinary legislative procedure: first reading)

### The European Parliament,

- having regard to the Commission proposal to Parliament and the Council (COM(2021)0108),
- having regard to Article 294(2) and Article 43(2), Article 114 and Article 168(4), point
  (b) of the Treaty on the Functioning of the European Union, pursuant to which the Commission submitted the proposal to Parliament (C9-0094/2021),
- having regard to Article 294(3) of the Treaty on the Functioning of the European Union,
- having regard to the opinion of the European Economic and Social Committee of 9 June 2021<sup>1</sup>,
- after consulting the Committee of the Regions,
- having regard to the provisional agreement approved by the committee responsible under Rule 74(4) of its Rules of Procedure and the undertaking given by the Council representative by letter of 8 September 2021 to approve Parliament's position, in accordance with Article 294(4) of the Treaty on the Functioning of the European Union,
- having regard to Rule 59 of its Rules of Procedure,

- having regard to the report of the Committee on the Environment, Public Health and Food Safety (A9-0195/2021),
- 1. Adopts its position at first reading hereinafter set out;
- 2. Calls on the Commission to refer the matter to Parliament again if it replaces, substantially amends or intends to substantially amend its proposal;
- 3. Instructs its President to forward its position to the Council, the Commission and the national parliaments.
