

It is particularly important that the Commission carries out appropriate consultations during its preparatory work, including at expert level. The Commission, when preparing and drawing-up delegated acts, should ensure simultaneous, timely and appropriate submission of the relevant documents to the European Parliament and to the Council.

The report shall, if appropriate, be accompanied by a legislative proposal to further streamline cooperation and coordination in establishing standards to
