*Decisions:*

- *TRAN Coordinators agreed in principle on an urgency procedure (Rule 163) provided that we receive reassurance from the Council (possibly in written) that the scope of the proposal is limited to the summer period 2021 with a maximum extension to the following winter period by the delegated act. Recommendations of the Worldwide Airport Slot Board (WASB) should also be taken into account.*
- *Mr Riquet (Renew) would liaise with the Commission and the Council, give feedback to Coordinators and collect their inputs, for a final decision by the end of this week in writing.*

**Agreement on the international occasional carriage of passengers by coach and bus (Interbus Agreement) by extending the possibility of accession to the Kingdom of Morocco**

*Cinneadh: TRAN Coordinators invite the Rapporteur, Mr Schulze (EPP), to continue following negotiations.*

**EU-US Agreement with Respect to Time Limitations on Arrangements for the Provision of Aircraft with Crew**

*Cinneadh: TRAN Coordinators invited the Rapporteur, Ms Maria Grapini (S&D), to launch the consent procedure.*

**EU-UK Trade and Cooperation Agreement**

*Cinneadh: TRAN Coordinators decided on an opinion in the form of a letter for the consent file.*

**Guidelines for trans-European energy infrastructure and repealing Regulation (EU) No 347/2013**
