1. DECISIONS TO BE TAKEN

1.1. Approval of the agenda

The draft agenda was adopted.

1.2. Announcements by the Chairwoman

Mr Ujhelyi (Vice-Chair) replaced Ms Delli as the Chair.

1.3. Nominations of rapporteurs/draftspersons

Amended proposal for a Regulation of the European Parliament and of the Council on Union guidelines for the development of the trans-European transport network, amending Regulation (EU) 2021/1153 and Regulation (EU) No 913/2010 and repealing Regulation (EU) 1315/2013

Decision: TRAN Coordinators agreed that the amended proposal be considered in the ongoing legislative report on the revision of the TEN-T (Co-rapporteurs: Barbara Thaler (EPP) and Dominique Riquet (RENEW)).

Amending Council Regulation (EEC) No 95/93 as regards temporary relief from the slot utilisation rules at Community airports due to the COVID-19 pandemic

Decision: TRAN Coordinators agreed to apply the urgent procedure (Rule 163) and reconfirmed Mr Riquet as Rapporteur, together with the Shadows from political groups.

Repealing Regulation (EEC) No 1108/70 of the Council introducing an accounting system for expenditure on infrastructure in respect of transport by rail, road and inland waterway, and Commission Regulation (EC) No 851/2006 specifying the items to be included under the various headings in the forms of accounts shown in Annex I to Council Regulation (EEC) No 1108/70

Decision: TRAN Coordinators allocated this report to ID (1 point).

Application of Articles 93, 107 and 108 of the Treaty on the Functioning of the European Union to certain categories of State aid in the rail, inland waterway and multimodal transport sector

Decision: TRAN Coordinators allocated this opinion to Greens according to the rotation system for opinions (0 point).

1.4. TRAN opinion to INTA, AFET and AFCO concerning Regulation on the Union's rights in enforcing and implementing the UK Withdrawal Agreement and the EU-UK Trade and Cooperation Agreement - 2022/0068(COD)

Decision: TRAN Coordinators endorsed the draft opinion to be voted.

1.5. Planning of 2023: TRAN missions / hearings / activities with national parliaments

Decision: The Coordinators will make proposals for the planning for 2023 by **Wednesday 7 September at noon**, on a) possible destinations and scope of committee missions, b) possible themes and scope of public hearings, and c) possible activities
