DECISIONS TO BE TAKEN

1.1. Approval of the agenda

Point 2.1 was cancelled and the draft agenda was adopted with that change.

1.2. Announcements by the Chairwoman

The Chair informed the Coordinators regarding:

- *The new integrity and transparency rules, that entered into force on 1 November 2023, in particular the mandatory inclusion of a “legislative footprint” in all final reports and opinions and the obligation for rapporteurs and shadow rapporteurs to introduce a declaration on a possible conflict of interest. The Secretariat will circulate further guidance on the implementation of these obligations;*
- *The foreseen timetable of the joint ENVI - TRAN file “Accounting of greenhouse gas emissions of transport services”. The Coordinators agreed to hold the joint ENVI-TRAN vote on Monday 4 March 2024;*
- *Rapporteur from Bureau on “Omnibus files” attributed in previous meeting - the files were attributed to Vice-Chair Oetjen.*

1.3. Nominations of rapporteurs/draftspersons

- **Amending Council Directive 92/106/EEC as regards a support framework for intermodal transport of goods and Regulation (EU) 2020/1056 of the European Parliament and the Council as regards calculation of external costs savings and generation of aggregated data**

- to attribute to EPP both the opinion on the General Budget of the European Union and the budgetary amendments to the Draft General Budget;

- to draft an opinion in the form of a letter on the Guidelines for the Budget 2025, due to the tight timetable in the main Committee. The Secretariat will circulate further details regarding the timetable.

Decision: TRAN Coordinators took note of the TTF activities in the second half of 2023 and approved the TTF work programme for the first half of 2024.

1.5. Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions proposing a European Declaration on Cycling - COM(2023)0566

Decision: TRAN Coordinators decided that the negotiation team for the European Declaration on Cycling will be composed of the TRAN Chair and the 2 co-rapporteurs of TEN-T and that the Coordinators will be kept closely informed regarding the EP mandate and the interinstitutional negotiations.
