### Dear Kaja Kallas,

I am writing at the recommendation of Schaake Marietje that you be considered for participation in the 2016 Young Leaders Conference being organized by the Council for the United States and Italy (www.consiusa.org). As you may know from Marietje, she had been selected to participate, but then, for reasons beyond her control, she had to withdraw. As we would have regretted there not being a representative of the European Parliament among our participants, we are undertaking a rapid search for a well qualified one. Just to whet your appretite, people like Enrico Letta, the former Italian Prime Minister and the former President of Mexico, among various political figures, and many US and Italian MPs or US Congressional members are alumni of the program. Of course, many of the other alumni come from other sectors...

Let me describe our annual conferences, this year's version, and the selection process.

The Council's annual Young Leaders Conferences bring together 40-50 people **under age 40**, consisting of three groups of more or less equal numbers from the United States, Italy, and a contingent from several other countries (12 were represented last year) to discuss a subject of common interest. The venue of the conference alternates between the US and Italy, and the subject changes every year. The conference is built around discussion of a topic that is selected for its intrinsic importance, presumed interest to participants, and general global relevance.

The objectives of our Young Leaders Conferences are to enable the participants to gain new perspectives on an important economic, political, or social issue, and to develop new international connections and friendships. The participants are selected on the basis of their record of accomplishment, leadership qualities, and growth potential in their respective fields of endeavor, which cover the spectrum from academia and business to government, media, and nonprofit/nongovernmental organizations. This is not a conference of experts. Participants will have varying degrees of knowledge and competence on the conference subject; the key is that they be prepared to engage actively in the discussions.

This year's conference – our  $32^{nd}$ - will be held in **Naples**, Italy, on **October 6-8** (starting in the afternoon of the  $6^{th}$  and ending early afternoon on the  $8^{th}$ ). The conference subject will be "Coping with disruption - How traditional personal, business and political models are being challenged in a turbulent world". Details are contained in the attached descriptions of the conference and topic.

I hope you will want to be considered for participation in this conference. If so, you will need to send me **your CV** and – if you wish - any other information you believe would be relevant to our in the selection process. Your CV should include – as relevant - nationality/nationalities, date of birth, professional experience, education and training, languages, publications and appearances, awards, other activities so that we can consider your candidacy. Also, an indication of what you might contribute to the conference would be helpful.

The acceptance of our invitation entails a commitment to be present – and participate actively – during the entire conference, which will officially start mid-afternoon on Thursday, October 6, and end mid-afternoon on Saturday, October 8.

I should point out that the selection process is very competitive: every year many more individuals are nominated than can be accommodated (about 60-70 applications for 15 positions in each of the three contingents), and thus many well-qualified candidates will not be selected.

Finally, a word on the Council: It is a binational, nonprofit, nonpolitical organization, founded in 1983 to foster closer ties between the business communities of the US and Italy. As such, it provides a forum for expanding and deepening interchange and understanding on issues of mutual interest to our membership. Top US and Italian corporate and financial firms are represented at senior levels. The American Ambassador in Rome and the Italian Ambassador in Washington are ex officio members. The Council's chair is Sergio Marchionne, CEO of Fiat Chrysler Automobiles.

I look forward to hearing from you. Needless to say, I will be happy to answer any questions you may have, and would appreciate having a skype conversation with you if you are indeed interested.
