Dear Mr. Jørgensen,

We have the pleasure to invite you to attend the 12th Int. HCH and Pesticides forum from 6-9 of November 2013 in Kiev!

As you have already heard, the Ministry of Environment will organize a special programme for you so you can meet the important representatives from the Ministry of Environment on all important issues of management of obsolete pesticides and from the Ministry of Agrarian Policy and Food of Ukraine on the issues of pesticides management and other related persons and a visit to Chernobyl.

Now 10 years after the 7th Int. HCH and Pesticides Forum had taken place in Ukraine in 2003, Ukraine and other countries in the region have been working hard to improve the situation, in spite of the difficult economic situation. We are proud to say that the Ukrainian government have now completed inventories, repacked and exported for final destruction more than 30,0000 tons of obsolete pesticides and the government has expressed to hope that soon obsolete pesticides will be a problem of the past for the country. These actions will also ensure the quality of food produced is maintained and free from harmful chemical residues.

The Forum has now grown as an integral part of the presently ongoing EU-FAO project on Capacity building on pesticide management in the FSU countries. Discussions are on also on-going with other institutions and development partners involved in trying to solve this problem including the Arctic Contaminants Action Programme (ACAP), EBRD, GEF, NEFCO, World Bank, UNDP and UNEP.

We would therefore like to take this opportunity to invite you personally to join a high level sessions aimed at mapping out the long term solution to the challenges facing the region from this problem. Only by cooperation and partnership will we be able to ensure our natural resources are safeguarded for future generations. You have shown over many a years now strong leadership and commitment for the

solution of the problems of obsolete pesticides in FSU region, and we hope that you can make a strong political statement which will have strong impact on the FSU governments, the EU commission and other international stakeholders to join forces for reaching this common goal. Together with other politicians we invite you to join the moderated session for politicians.

The discussions will be held at the International Convention Center "Ukrainian House".
