Allow ample time for pre-boarding procedures. The time indicated on your ticket is the time the aircraft is scheduled to leave the gate, not the time you need to check in. Check-in time is more or less two hours before boarding time. In busy periods, it is advisable to allow extra time. If you check in after the designated time, you may miss your flight. Flights will not be held for passengers arriving late.

=> For flights within Europe: at least 1.5 hours before boarding time

=> For flights outside Europe: at least 2 hours before boarding time
