(repeated from my previous Declaration)From 14 to 20 May 2011 I took part in a visit of the EP-Taiwan Friendship Group to Taiwan. My return business class air ticket and all ccommodation, meals and travel within Taiwan were provided by the Taiwanese authorities. I was accompanied by my wife and I paid from my own private account all the costs of her air travel. I received a number of small gifts in the course of the visit, none of which were valued at more than €50.

(repeated from my previous Declaration) During the period 23-29 November 2011, I flew to Sri Lanka, accompanied by my wife, in my capacity as Chairman of the 'Friends of Sri Lanka' Group in the European Parliament. Once we reached Sri Lanka our accommodation, hospitality, security and transport were provided by the Government of Sri Lanka. During the visit, I was presented with books and other small gifts of value less than €50.

(I) Any additional information I wish to give³:

This declaration relates to the period 1 January 2011 - 31 March 2012. Details of my parliamentary expenses and allowances and of lobbying contacts are contained respectively on the Right to Know form and the annual Lobbying Contacts form posted on the British Conservative delegation website. I employed 3 Assistants (until Sep 20011, when this temporarily was reduced to 2): 3 full time and 1 part time including my wife who received payment in the band £0-10,000. All payments are made in accordance with the Parliament's rules either directly by the Parliament or through a Paying Agent, an independent firm of chartered accountants responsible for payroll activities relating to locally employed personnel including deduction for UK income tax, national insurance etc as appropriate. As a consequence of the introduction of the Members' Statute, I now pay so-called 'Community Tax' on my salary - however, in addition, I have voluntarily agreed to pay UK income as have my Conservative MEP colleagues, so that I continue to pay UK tax on my income at the same rate as my constituents.
