☒ parliamentary procedure or negotiations: **On 21 June 2019, at its 108th session, the International Labour Conference adopted Convention 190 concerning the Elimination of Violence and Harassment in the World of Work ('ILO Convention 190'), accompanied by Recommendation 206. It is the first international instrument setting out specific, globally applicable standards on tackling work-related violence and harassment. All EU Member States supported the objectives of this Convention and played a key role for its adoption. On 22 January 2020, the European Commission presented a proposal for a "Council Decision authorising Member States to ratify, in the interest of the European Union, the Violence and Harassment Convention, 2019 (No. 190) of the International Labour Organization" On 18 September 2023, the Council adopted its position on a draft decision inviting Member States to ratify the ILO convention 190 adopted by the International Labour Organization. The Council decision inviting Member States to ratify the violence and harassment convention will be formally adopted once the European Parliament has given its consent. The FEMM and LIBE committees of the European Parliament will provide the lead EMPL committee with an opinion. This non-legislative enactment requires the consent of the European Parliament.**
