III. JUSTIFICATION

2024/03 "Energy consumption: Brussels"

+ € 600 000

- 1. This appropriation is intended to cover, in particular, water, gas, electricity and heating costs.
- 2. The amount allocated to the sub-item in the 2006 budget is \notin 5 687 208.

This proposal is intended to request the transfer of \notin 600 000 from chapter 101 "Contingency reserve" to sub-item 2024/03 "Energy consumption: Brussels" to enable the Parliament to cover additional expenditure on energy for Brussels due to the increased energy consumption and the strong price rise.

- 3. The 2006 budget was prepared on the basis of expenditure incurred in 2004. In the meantime the price of energy has increased in Belgium because of the introduction of a free market, and, of course, the strong increase in the basic price of oil.
- 4. The price of electricity rose by 39.14% from 6.1355547 cent/kWh in 2004 to 8.5367105 cent/kWh in 2006. In the same time period, the gas price even jumped by 51.73% from

2.194716 cent/kWh to 3.3301169 cent/kWh. These increases are higher than expected at the time when the budget 2006 was prepared.

- 5. In addition, fluctuations of temperature due to the extraordinary climatic conditions during the months of May, June and July this year strongly increased the energy consumption of the Institution. 2006 expenditure for these 3 months alone showed an increase of € 517 000 over 2004, and € 310 000 over 2005.
- 6. In order to cover the additional expenditure a top-up of $\in 600\ 000$ of the budget line in question is requested.
- 7. The amount is available in chapter101 "Contingency reserve" and may be taken from there.
- 8. In the circumstances, it is proposed that € 600 000 be transferred from chapter 101 "Contingency reserve" to sub-item 2024/03.
