III. JUSTIFICATION

2370/01 "Removals: departmental removals and associated handling"

+ € 100 000

- 1. This appropriation is intended to cover the cost of removal and handling work carried out by removal firms or by temporary handling staff supplied by outside agencies.
- 2. The amount allocated to the sub-item in the 2006 budget is \in 355 000.

The purpose of the present proposal is to request the top-up of sub-item 2370/01 "Removals: departmental removals and associated handling" by \in 100 000 required to cover additional expenditure following the occupation of new offices.

- 3. The amount spent on this item decreased from € 608 034 in 2004 to € 502 203 in 2005. The initial appropriation for 2006 was lower still at € 355 000. However, as a result of developments in the course of the year, this has proved insufficient.
- 4. So far, practically the total amount of € 355 000 has been committed.
- 5. Expenses were covered by the 2006 budget as a result of decisions which could not have been foreseen when the preliminary draft estimates were prepared (late 2004/early 2005).
- 6. These were:
 - the Bureau decision of 27 April 2005 to occupy the Montoyer 75 building and the subsequent move of DG Info to that building;
 - the administrative decision to occupy additional offices in the "Banane" building in rue Wiertz.
- 7. These expenses were covered by appropriations in the 2006 budget which had been earmarked for work normally foreseen for 2006, including removals linked to the multi-annual renewal of office furniture which is underway in Luxembourg and Strasbourg.
- 8. The requested amount of € 100 000 is therefore necessary in order to continue the normal work programme of 2006 and to ensure the transport of material to and from Strasbourg for the remaining parliamentary sessions this year.
- 9. The amount is available in chapter 101 "Contingency reserve" and may be taken from there.
- 10. In the circumstances, it is proposed that € 100 000 be transferred from chapter 101 "Contingency reserve" to sub-item 2370/01 "Removals: departmental removals and associated handling".
