1. Adoption of draft agenda

The draft agenda was adopted.

2. Approval of minutes of meeting of 4 December 2005

The minutes of the meeting of 4 December 2005 were approved.

3. Chairman's announcements

- More than 100 parliamentarians had taken part in the third meeting between European and Latin-American Integration Parliaments held in Bregenz (Austria) on 24 and 25 April 2006. The European delegation had been chaired by President BORRELL FONTELLES. The participants had adopted a final declaration including a message to the Head of State or Government taking part in the Vienna Summit.
- At the Fourth Summit of EU-LAC Heads of State or Government held in Vienna on 11, 12 and 13 May, the Commission had been given a mandate to open negotiations for an Association Agreement with Central America. The Summit also decided to set up a Euro-Latin American Assembly.

4. Exchange of views on 'femicidios'

Mrs Andrea MEDINA ROSAS of the Latin American and Caribbean Committee for the Defence of Women's Human Rights (CLADEM) in Mexico and Mr Onésimo HIDALGO of the Centre for Economic Research and Community Action Policies (CIEPAC) introduced an item on the killing of women, with reference the law recently adopted by the Mexican Chamber of Deputies with a view to combating violence against women. They stressed the need for:

- follow-up to ensure that the general law on access for women to a violence-free life was adopted by the Mexican Senate;
- the EU-Mexico Delegation to familiarise itself with and share the new information on the killing of women in various federal states in Mexico;
- economic and technical support in enhancing access to justice for women and the families of victims of 'femicidio'.
