of the meeting of 11 October 2011, from 16.30 to 18.30  
Brussels

The meeting opened at 16.35 on Tuesday, 11 October 2011, with Christian Ehler (Chairman) in the chair.

**1. Adoption of draft agenda (PE 470.622)**

The draft agenda was adopted without modification.

**2. Adoption of the draft minutes of the meeting on 14 September 2011 (PE 470.624)**

The draft minutes were adopted without modification.

**3. Chairman's announcements**

The Chairman pointed out that due to the general elections scheduled to take place in the Republic of Korea in 2012 it is uncertain when the next inter-parliamentary meeting between both assemblies can take place. Further contacts will be needed with interlocutors in the Korean National Assembly. Members will be informed as soon as some possible dates are identified.

**4. Briefing by the EEAS on latest developments in relations between the European Union with the Democratic People's Republic of Korea and the Republic of Korea**

The representative of the European External Action Service, Mr Bram Brands, made a presentation on latest developments in relations between the European Union and the Democratic Peoples' Republic of Korea. He underlined that the position of the EU as regards the nuclear issue remains unchanged: this question still poses a serious threat not only to stability on the Korean peninsula, but for the security of the entire region. Therefore, dismantlement must remain the objective. Although not being part of the Six-Party-Talks, the EU still takes the view that this forum is the most appropriate for

reaching a diplomatic solution and hopes that the talks can be resumed in the close future, as some positive signals were noted in the last months.

Reference was also made to the tense inter-Korean relations in 2010, with some positive developments noted in 2011. As regards food security, the representative of the EEAS reported on the recent mission of ECHO to North Korea, which concluded that the food supply situation for vulnerable groups is worsening. Last but not least, Members were also briefed about the wish of North Korean Authorities to open an embassy in Brussels. It was noted that there is no majority in Council for such a move at the moment, which would also depend on further developments.

Mr Marcel Roijen (EEAS) briefed Members on the latest developments in relations with the Republic of Korea, and referred, in particular, to the implementation of the revised EU-Korea Framework Agreement, the EU-Korea Free Trade Agreement, and the need to add more concrete added value to the EU-Korea Strategic Partnership.

The following Members participated at the subsequent exchange of views: Simon, Rosbach, Häfner, and the Chairman. Reference was made to the nature of the European Union's food aid to North Korea, which can not really be seen generally as emergency aid, but rather addressing a systemic problem.

**5. Exchange of views on the draft programme and draft agendas for the forthcoming official visit to North and South Korea, scheduled from 28 October to 5 November 2011**

The draft programme and draft agendas were approved as presented by the Chairman.
