14. Chairman's announcements concerning coordinators' decisions

- Follow-up decisions concerning the further discussion of the petitions on the impact of the 'Ley de Costas' on the rights of European citizens and residents to their individual property (April & May meetings).
Decisions:
 - a) The petitions falling under the Auken Report should be gathered together and reconsidered, notably with regard to the recent ECJ decision;

- b)** more detailed information regarding the ongoing debate for the revision of the Coastal law in the Spanish Parliament is to be obtained from the Spanish authorities;
 - c)** once the information is received, the possibility of presenting a report to plenary on this issue should be considered by the Coordinators at a later meeting;
 - d)** a workshop is proposed on the *Ley de Costas* in the Petitions Committee to better assess the legal aspects of the issue and its link with European law;
 - e)** to take this topic into consideration for the agenda of the proposed hearing on the Charter of Fundamental Rights scheduled for October 6th;
 - f)** a detailed letter to the petitioners is to be sent explaining the decisions taken.
- Fact-finding visits to Bulgaria and to Berlin:
Decision: Approval of the draft programme for the visit to Bulgaria.
The fact finding visit in Berlin was postponed.
- Consideration of a joint Oral Question with the Fisheries Committee.
Decision: postponed until the forthcoming hearing of the EPP on the same issue had taken place and pending further consultations with PECH.
- Further consideration of a request by Mr Klein.
Decision: letter to the Commission concerning the respect of the previous decisions and invite the competent Commissioner to insist with the German authorities on the need for a further meeting to review the situation. The creation of a Committee of inquiry as suggested by the petitioner was not considered appropriate.
- Confirmation of a request to establish a report on Citizenship.
Decision: approval on the preparation of an INI report on European Citizenship in the light of the agreement reached with LIBE (Rapporteur Adina-Ioana Valean-ALDE).

Consideration of the draft agenda for the meeting of July 12 & 13, and consideration of a request by the EPP to add, under the urgency procedure, consideration of the petitions tabled on the budget of the European Schools.

Decision: Approval of the Agenda with the item on European Schools, all interested parties to be invited, if no objections within 48 hours. (After this deadline, no objections were received by the Secretariat).

The Coordinators asked an urgent discussion on the issue of the air traffic controllers in Spain and Europe, especially concerning the aspect of security, and an opinion to TRAN Committee.

Members expressed their concern that the Single Market provisions and those related to free movement and rights of establishment still allowed such anomalous situations to persist to the detriment of the rights of EU citizens.

Decision: Petitions remain open, pending letter to the national authorities concerned who would be invited, when the petitions would be discussed again; pending further information from the Commission (on their inquiry and on their future proposal concerning barriers to cross-border activity).
