The European Parliament,

- having regard to the proposal for a Council decision (COM(2020)0856),
- having regard to the draft Trade and Cooperation Agreement between the European Union and the European Atomic Energy Community, of the one part, and the United Kingdom of Great Britain and Northern Ireland, of the other part (xxxx/2021),
- having regard to the draft Agreement between the European Union and the United Kingdom of Great Britain and Northern Ireland concerning security procedures for exchanging and protecting classified information (xxxx/2021),
- having regard to the request for consent submitted by the Council in accordance with Article 217 and Article 218(6), second subparagraph, 218(7) and 218(8), second subparagraph of the Treaty on the Functioning of the European Union (xxxx/2020),
- having regard to its resolution of 12 February 2020 on the proposed mandate for negotiations for a new partnership with the United Kingdom of Great Britain and Northern Ireland,¹
- having regard to its recommendation of 18 June 2020 on the negotiations for a new partnership with the United Kingdom of Great Britain and Northern Ireland,²

and Committee on Constitutional Affairs,

- having regard to the recommendation of the Committees on Foreign Affairs and on International Trade (A9-0000/20201),
 1. Gives its consent to the conclusion of the Trade and Cooperation Agreement between the European Union and the European Atomic Energy Community, of the one part, and the United Kingdom of Great Britain and Northern Ireland, of the other part, and of the Agreement between the European Union and the United Kingdom of Great Britain and Northern Ireland concerning security procedures for exchanging and protecting classified information;
