**MINUTES**

of the meeting of 16 February 2017, 9.00-10.30  
Strasbourg

The meeting opened at 9.10 on Thursday 16 February 2017, with Teresa Jiménez-Becerril Barrio (PPE, ES), Chair, in the chair.

**1. Adoption of draft agenda (PE 543.328)**

The draft agenda was adopted.

**2. Approval of minutes of meeting of 26 January 2017 (PE 543.326)**

The draft minutes of the meeting of 26 January 2017 were approved.

**3. Chair's announcements:**

The Chair told members that they could find a letter in their folders from the Chair of the S&D Group, Gianni Pitella, to the President of the EP, Antonio Tajani. The letter called for the President of the United Mexican States, Enrique Peña Nieto, to be invited to the EP as a clear display of solidarity between the EU and Mexico following the recent stances taken by the Trump administration. The letter also insisted on a strengthened Strategic Partnership, as well as on successfully concluding the EU-Mexico negotiations aimed at signing an updated global agreement.

The Chair reminded those present that the Programme of Activities for the first half of 2017 included the 22nd meeting of the EU-Mexico JPC, to be held in Mérida, Mexico, from 22 to 23 February 2017. The details of the visit would be discussed in the next item of the agenda.

The Chair also told members that the 23rd meeting of the EU-Mexico JPC would be held in Brussels in the second half of 2017 (date to be confirmed).

The Chair told members that, in her capacity as Chair of the EP Delegation in the EU-Mexico Joint Parliamentary Committee, and taking into consideration the recent decisions made by the Trump administration concerning Mexico, she had prepared a statement expressing solidarity with the United Mexican States.

#### **4. Preparation of work for the 22nd EU-Mexico JPC meeting to be held in Mexico from 22 to 23 February 2017**

To prepare for the 22nd meeting of the EU-Mexico JPC, which would take place from 22 to 23 February 2017 in Mérida, Mexico, the members present discussed organisational issues, expressed their complete solidarity with the Mexican nation and government against the racist and xenophobic statements made by US President Donald Trump, and insisted on the need to successfully conclude negotiations on the updated EU-Mexico Partnership Agreement.

#### **5. Date and place of next meeting**
