We had meetings with the Prime Minister; Leader of the Opposition; Speaker of the Parliament: the TNA (Tamil) Leader, Rajavarotheiam Sampanthan; and the Muslim Congress Leader, Rauff Hakeem, as well as the Director of the Lakshman Kadirgamar Institute and senior military officers and a field update on the landmine situation. All internal travel (car), accommodation, and some meal costs were met by the Sri Lankan authorities.</p>
