Visit **Barzilai Medical Center** in Ashkelon, and meeting **Dr. Ron Lobel,** hospital Emergency Coordinator, survivor of Moshav Netiv Haasarà massacre

Proceed to Sderot

Meeting with **Alon Davidi**, Mayor of the city of Sderot, or other officials from Sderot Municipality. Tour of Sderot with the testimony of **Ronen Gubbay**, Sderot security coordinator, who was injured on October 7, and **Ayelet Shmuel**, Director of International Resilience Center of Sderot

Proceed to Shuva Junction, meet with IDF to be escorted to Kibbutz area

Visit Kibbutz Be'eri and Kfar Azza, accompanied and briefed by IDF officer

Proceed to the Bedouin city of Rahat

The Arab-Israeli Society in the Aftermath of the Attack, meeting with victims and heroes from the Bedouin society: Hamed Abu Arar, whose wife Fatima was killed by the terrorists in front of his eyes; Yousef Ziadna, who saved dozens of lives from Nova Festival; Ali Ziadna, whose brother and three nephews are held hostages in

Gaza; and with **Fouad Ziadna**, founder of the Jewish-Arab civil volunteer center of Rahat

Proceed to Carlton, Tel Aviv Hotel

Meeting with **Dr Einat Wilf**, author and former Member of the Knesset (Labour)

Overnight: Carlton Hotel, Tel Aviv

Tuesday, November 28, 2023 - Day 3

Meeting with **MK Alon Schuster**, former Deputy Minister of Defense and former Head of Sha'ar HaNegev Regional Council

Visit **Shura Military Base**, now serving as the main center for victim identification
