Suggested title

Tax harmonization in Europe. Consequences to the EU budget.

Draft concept note

Tax competition has led Member States to a difficult race-to-the-bottom in their tax collection capacity, being thus European policies and at last, its citizens, jeopardised.

The European Commission is trying to legislate on some harmonisation focused on taxes levied on goods and services, like value added tax or corporate income tax, but Member States have to delegate sovereignty to the EU in order to achieve so.

Tax scandals of avoidance or fraud are more than ever on G20 and EU's political agenda. The Offshore leaks, Luxleaks, Swissleaks or the Panama Papers have evidenced how serious the problem is and demonstrating again the need for greater European coordination and harmonisation on tax matters. Also, state aids via tax benefits from some countries have lately been a highlight on tax matters.

Even progress on this matter is still limited, tax harmonisation is a clear goal to be achieved for a sound internal market functioning.
