Parliament and Council negotiators reached a provisional agreement on both the regulation and the directive last December. Plenary will hold a joint debate on Wednesday and vote Thursday.

The Council of Ministers is expected to formally adopt the data protection package (regulation and directive) by Monday 11 April to enable the Civil Liberties Committee to hold a vote on its second reading recommendations to plenary on Tuesday 12 April.

## Final vote on the EU Passenger Name Record (PNR)

MEPs will vote on Thursday on the EU Passenger Name Record (PNR) directive, which will oblige airlines to hand EU countries their passengers' data in order to help authorities to fight terrorism and serious crime. Plenary will hold a debate on the subject Wednesday afternoon, after a discussion on the data protection package.

Parliament negotiators reached an agreement with Council on the PNR directive last December, which was endorsed by the Civil Liberties Committee that same month.

MEPs sought to ensure, in three-way talks ("trilogues") with the Council and Commission that the draft law complies with the proportionality principle and includes strict personal data protection safeguards.

PNR data is information provided by passengers and collected by air carriers during reservation and check-in procedures, such as travel dates, travel itinerary, ticket information, contact details, baggage information, payment information, etc.

### **EU-Turkey deal up for a debate**

The agreement to return migrants and asylum seekers from the Greek islands to Turkey, reached at the meeting of heads of state or government on 18 March in Brussels, will be at the centre of a debate with Council President Donald Tusk and Commission President Jean-Claude Juncker on Wednesday morning.

Under the new agreement, all people arriving irregularly from Turkey to the Greek islands are to be returned, and the EU is to take in one Syrian refugee for each Syrian sent back. Once irregular crossings from Turkey have been substantially reduced, a Voluntary Humanitarian Admission Scheme will be activated. The deal also opens up prospects for faster visa liberalisation for Turkish citizens traveling to the EU, provided Ankara complies with the requirements.

#### Turkey's 2015 reform efforts under scrutiny

Following the first debate, Parliament will also discuss the **2015 reform efforts of Turkey towards EU membership** with Enlargement Commissioner Johannes Hahn on Wednesday and vote on a resolution on Thursday.

The draft says that EU-Turkey cooperation on migration should be uncoupled from the EU accession negotiating process and flags areas that are lagging behind in the reform process, such as the rule of law, freedom of expression and fundamental values.

## EP to call for centralised EU asylum system and legal ways to migrate

A centralised asylum system would allow the EU to better manage the increasing flows of migrants and asylum seekers, according to a draft resolution MEPs will debate and vote on Tuesday. The text advocates safe and lawful ways for third-country nationals to enter the Union without risking their lives and resorting to criminal smugglers.

The draft resolution, prepared by Roberta Metsola (EPP, MT) and Kashetu Kyenge (S&D, IT) demands a radical overhaul of the so-called Dublin rules (which determine the member state responsible for processing an asylum application) to ensure shared responsibility, solidarity and quicker processing of asylum claims. It also calls on member states to honour their commitments regarding relocation of refugees and insists on the need for a binding EU resettlement scheme.

### "Panama Papers" tax scandal debate

The "Panama Papers" revelations about more than 200,000 offshore companies and their secret owners, including many politicians and celebrities, will be debated with the Commission and Council on Tuesday afternoon. The key question: Are existing EU measures against tax evasion and money laundering working?

The Panama Papers were revealed by the International Consortium for Investigative Journalism, the organisation behind the so-called "Luxleaks" corporate tax scandal of 2014. "LuxLeaksdrew up a long list of legal recommendations for fairer and more transparent tax policies in the EU.

#### Registering beneficial ownership

Thanks to Parliament, mandatory registration of beneficial owners of companies became part of the Anti-Money Laundering Directive which Parliament approved in May 2015 (deadline for transposition is 26 June 2017). Although not public, this information must be made accessible for competent authorities (tax, law enforcement) and "persons with a legitimate interest".

#### Background on Panama Papers

The Panama Papers are a leaked set of 11.5 million confidential documents that provide detailed information about more than 214,000 offshore companies listed by the Panamanian corporate service provider Mossack Fonseca, including the identities of shareholders and directors of the companies. The documents show how wealthy individuals, including public officials, hide their money from public scrutiny.

## Calls for an EU-wide ban on glyphosate herbicide

As long as serious concerns remain about the carcinogenicity and endocrine disruptive properties of the herbicide glyphosate, which is widely used in farming, forestry and gardening, the EU Commission should not renew its market authorisation, says a non-binding resolution to be put to a vote on Wednesday.

The EU Commission should launch an independent review and disclose all the scientific evidence that the European Food Safety Authority (EFSA) used to assess glyphosate, the text says, rather than renewing its market approval for another 15 years without any restrictions.

Note for editors

The decision on authorisation has to be taken by national experts sitting in the Standing Committee on Plants, Animals, Food and Feed (Phytopharmaceuticals Section). It can adopt or reject the Commission proposal by qualified majority. If there is no such majority, it is up to the European Commission to decide.

Glyphosate is an active substance widely used in herbicides. Patented in the early 1970s, it introduced to the consumer market in 1974 a broad-spectrum herbicide. Since its patent expired in 2000, glyphosate has been marketed by various companies and several hundred plant protection products containing glyphosate are currently registered in Europe for use on crops.

# MEPs to approve extra funds for refugee aid and fighting terrorism

Parliament is set to give the go-ahead for 2016's first draft amending budget, to provide for €100 million of emergency support for refugees within the EU as well as €2 million to hire new staff at EUROPOL's European Counter Terrorism Centre (ECTC). Given the urgency, MEPs fast-tracked the procedure to be completed in just over a month.

The €100 million for humanitarian aid, in view of the current influx of refugees and migrants into the Union, is the first slice of the new €700m Emergency Assistance instrument proposed by the Commission on 2 March. The funds could be used for: food assistance, emergency healthcare, shelter, water, sanitation and hygiene, protection, and education.

In the light of recent terrorist attacks, a further €2 million would be made available to reinforce staff at the European Counter Terrorism Centre (ECTC), established at EUROPOL on 1 January 2016, which is expected to be the central hub in the fight against terrorism in the EU.

The funds for providing humanitarian assistance to refugees within the EU are redeployed from the Asylum, Migration and Integration Fund (AMIF) and those for Europol from the Internal Security Fund (ISF), thus not taken from existing external humanitarian aid programmes outside the EU.

Professor of Law Mr Rebelo de Sousa won the presidential elections with 52% of the votes in the first ballot, on 24 January 2016. He started his five year mandate on 9 March.

He was one of the founders of the People's Democratic Party, later the Social Democratic Party (PSD, member of the EPP group), and party leader from 1996 to 1999. Apart from his political and governmental positions, Marcelo Rebelo de Sousa was also involved in founding the Portuguese newspapers Expresso and Semanário. He has been a regular political commentator since the 1960s, first in newspapers and later on radio and television.

They might also reiterate their previous call for additional measures, including legislative ones, to strengthen farmers' positions and introduce more balance in the food supply chain.

MEPs will also discuss ways to make EU agriculture more resilient to any future shocks or disturbances beyond the EU's borders. They will probably call on the Commission to ensure farmers' access to flexible and innovative financial instruments to better protect their income and react promptly to market changes.

# MEPs to approve EU support for 500 former truck industry workers in Sweden

Parliament will vote on a proposal to grant €1,793,710 in EU aid to Sweden to help find new jobs for 500 workers made redundant by Volvo Trucks, mainly in the Umeå plant, and four suppliers and downstream producers.

The employees were laid off because European truck makers have lost market share to Asian ones in recent years. Volvo says that it has been forced to cut costs to tackle global competition.

## Fighting poverty: help poor families to cut heating bills

EU member states should impose a moratorium on winter heating disconnections, so that no household can be cut off from energy in the cold, says a draft resolution to be put to a vote on Thursday. To step up the fight against poverty in the EU due to growing household costs, MEPs call for more support for poor families and further investment in energy efficiency projects to reduce utility bills.

The non-binding resolution, drafted by **Tamás Meszerics** (Greens/EFA, HU), argues that the EU is getting further away from its 2020 strategy goal of bringing at least 20 million people out of poverty in the next four years. It also calls on the Commission to assess whether minimum income schemes in the EU enable households to meet basic needs. Adequate minimum income should be above the poverty threshold, which is approximately 60% of respective national median income.

Background for editors

Poor households spend the largest share of their income on food, housing and utilities. According to EU statistics on income and living conditions 10% of citizens had arrears on utility bills in 2015, 12% were unable to keep their home adequately warm in 2014, while 16% of the population were living in dwellings with leaking roofs and damp walls in 2014.

Between 2008 and 2013, the number of poor people in the EU increased from 117 million to 122.6 million: 16.7% of the population were at risk of poverty after social transfers, 9.6% were in a situation of serious material deprivation and 10.7% of households were considered to have very low work intensity.

## Parliament to give its verdict on six nominees to the European Court of Auditors

Parliament will vote on Wednesday on the nominations of auditors to the European Court of Auditors from Slovakia, Latvia, Czech Republic, Poland, Malta and Slovenia on the basis of recommendation from the Budgetary Control Committee. The final decision on appointments to the Luxembourg body will be taken by the EU Council of Ministers.

Members of the Court of Auditors are appointed for six years. The Council, after consulting the European Parliament, decides upon the proposals made by each member state. Before the plenary vote, the six nominees were heard in the Budgetary Control Committee (CONT) on 15 March, which recommended rejecting the candidates from Slovakia, Poland and Malta.

# International fisheries: stricter rules for fish products and vessels

The EU fisheries agreement with Mauritania should serve as a role model for transparency and enforcement, says a draft resolution on the external dimension of the Common Fisheries Policy (CFP) to be debated on Monday and voted on Tuesday. MEPs will call for stricter rules on imported fish products and sanctions against non-complying vessels.

Using the fisheries agreement with Mauritania as a role model for transparency means that any fish or fishery-derived product that does not comply with certain conditions or consumer protection requirements will be barred from European markets. An EU database covering all private agreements between EU shipowners and local and regional bodies, authorities and third countries, will also be created, among the key proposals included in the resolution drafted by Linnéa Engström (Greens/EFA, SV) to be put to plenary vote on Tuesday.

## New five-year EU-Greenland fisheries agreement

Under a new five-year-deal to be approved in plenary on Tuesday, EU vessels targeting mainly prawn, halibut, cod and redfish would be allowed to continue to fish in the waters of the Greenlandic Exclusive Economic Zone. In return, the EU would pay Greenland a financial contribution of €17.8 million per year. This Protocol follows the expiry of the 2013-2015 Protocol.

The Fishing Partnership Agreement (FPA) is a "mixed agreement", which permits the EU vessels to fish for a wide range of species. The first fisheries agreement between the EU and Greenland was concluded in 1985 for an initial period of ten years and thereafter extended for additional six-year periods until it was replaced by the FPAs. The first fisheries agreement was implemented by successive protocols.

Background

Greenland joined the European Communities (EC) as a part of Denmark in 1973, but left the EC following a referendum in 1985. Today, Greenland is one of the overseas countries and territories (OCT) of the Union. In 1979 Denmark granted 'Home Rule' to Greenland, and following a referendum in 2008 all functions of government rest with the Government of Greenland except for those related to defence, fisheries inspection outside the territorial waters, constitutional affairs, currency and monetary policy, which are retained by Denmark.

The Ministry of Fisheries, Hunting and Agriculture (MFHA) has overall responsibility for fisheries policy and the management of fish resources in Greenland.

Fish account for nearly 90 % of exported goods. Virtually all of Greenland's exports of fish products are destined for the EU, with Denmark accounting for more than 90 % of EU imports.
