Registration documents for vehicles. Transport MEPs will adopt their position on revised EU rules setting out common requirements for vehicle registration documents. The rules are part of the 2025 roadworthiness package and seek to cut red tape, combat fraud and introduce digital vehicle registration solutions. *(Wednesday)*

Economic dialogue. Members of the Economic and Monetary Affairs Committee will quiz Commissioner Valdis Dombrovskis on the implementation of the revised economic governance framework, which entered into force two years ago, and the implications of the current geopolitical developments for the European economy. *(Thursday)*

EU farmers. Agriculture MEPs are expected to greenlight the deal reached with EU governments on new measures to reinforce farmers' position in the food supply chain. The law aims to ensure fair prices for farmers' products and clarifies labelling and advertising rules. *(Wednesday)*
