BACKGROUND

In recent years, the safety of journalists has continued to deteriorate – physical and online threats and attacks on journalists are on the rise in several Member States. Moreover, the COVID-19 pandemic has exposed existing difficulties within the media industry and has given governments across the world a cover to exacerbate the recent worrying trends in press freedom, journalist safety, and media plurality.

“Strengthen media freedom and pluralism” is the second pillar of the European Democracy Action Plan (presented by the Commission on 3 December 2020). The European Parliament is organising this seminar as a continuation of a series focused on Democracy. The [first seminar](#) focused on the third pillar of the plan, **“Counter Disinformation”**. The first pillar of the Democracy Action Plan is **“Promote free and fair elections”**. Several initiatives are and will be proposed within this Action Plan before next European Elections in 2024.

Reporters Without Borders’ (RSF) [annual report](#) and index on press freedom has highlighted diverging trends within the European Union, and has led to calls for action to ensure the media are protected. While EU Member States such as Finland, Sweden and Denmark are world-leaders in ensuring a free press, others like Bulgaria, Hungary and Malta are lagging behind in the index with some of the lowest rankings. Worryingly, Poland dropped to its lowest ranking ever on the index.

According to RSF’s ranking, violence against journalists is becoming more prevalent across the EU. We cannot forget the murders of Jan Kuciak and Daphne Caruana Galizia in Slovakia and in Malta, respectively. In Germany and Italy, reporters have been attacked by members and supporters of extremist and conspiracy-theory groups, while journalists have been the victims of police violence and arbitrary arrests in Greece and France.

The European Union and its European Democracy Plan addresses the decline in media freedom. EU Internal Market Commissioner Thierry Breton recently called for additional legislative tools to be made available to the EU to combat the “worrying development” of press freedom and media plurality in Member States such as Poland, Hungary, Slovenia and the Czech Republic. Among the proposals is a **European Media Freedom Act** to ensure that media freedom remains a “pillar of our democracies”.

The European Parliament is pushing for anti-SLAPP (Strategic Lawsuits Against Public Participation) with work on an own initiative report starting in the LIBE and JURI committees in the coming weeks.

Daphne Caruana Galizia Prize for Journalism

The European Parliament has recently [approved \(October 2020\)](#), the Daphne Caruana Galizia Prize for Journalism. An external organisation has been chosen (following a call of tenders) to implement the project. The prize will be judged by a panel of independent journalists and provide **€20,000 funding** in prize money. The date of the award ceremony

will be around the 16th of October. The prize will distinguish outstanding journalism revolving around the principles and values of the European Union. This Prize is named after the murdered Maltese journalist to honour her memory and support journalists and the vital work they do.

The way the Prize will be managed will mean that MEPs will not be involved to ensure its political impartiality. Therefore it will be handled entirely by an independent private organisation tasked with selecting a highly competent and independent jury to select the winning piece from nominated works of in-depth investigative journalism dealing with topics touching upon the EU values and rights enshrined in the EU charter of Human Rights.
