The leader of the group must be the same for both lots. The composition and constitution of the consortium and the allocation of the scope of tasks amongst the members shall not be altered without prior written consent of the EP which can be withheld at discretion.

The consortium of economic operators shall provide proof of its legal form by the time the contract — if awarded to it — is signed. This may take one of the following forms:
