Sommarju Aiming to feed into the forthcoming Conference on the Future of Europe and debate in the European Parliament on possible reforms of the 1976 European Electoral Act, this paper from the European Parliamentary Research Service analyses the main proposals to create a European constituency (or constituencies), in which Members of the European Parliament would be elected from transnational electoral lists. Such proposals have been discussed over the years in the European Parliament itself, as well as in other European and national institutions and academia. Following a review of these proposals, the paper then details the legal changes that would be needed at European and national levels to bring the idea to fruition.

Sommarju The election of the European Parliament by direct universal suffrage in 1979 was a groundbreaking democratic event in that it profoundly changed the character, composition and functioning of the Assembly and its political influence in the institutional set-up of the European Community. The impact of this change extended to areas as diverse as the organisation of parliamentary business, the workings of parliamentary committees and intergroups, increased budgetary powers, the socio-professional profile of MEPs, the role of political groups, relations between MEPs and the Administration, changes in the Secretariat's establishment plan, relations with lobbyists, communication policy, the Assembly's activities in the context of the European Community's values and interinstitutional relations.

Sommarju First published in May 2008, this latest Review of European and National Election Results, produced by the Public Opinion Monitoring Unit of DG Communications, contains detailed information about the May 2014 European elections, and looks back on 35 years of direct elections to the European Parliament since 1979. The opening chapters are dedicated to historic trends defining changes in the composition of the EP, political groups and gender balance among MEPs since 1979. They chart the Parliament's progress, following the adoption of Treaties and the accession of new Member States, with the number of MEPs having increased from 410 in 1979 to 751 today. An important section of this Review looks closely at the turnout figures. Although overall turnout in 2014 remained stable, at 42.61% (compared with 42.97% in 2009), individual trends since 2009 vary widely from one country to another - from 26.37 points up in Lithuania to 23.46 points down in Latvia. In the last chapter, the reader will find several tables, for each Member State, detailing the results of the 2014 European elections (national parties represented, MEPs elected, national lists, etc.), as well as the results of the two last national parliamentary elections, and of presidential ones, where direct election applies.

Sommarju Egypt's political influence stems from its strategic geographic position, historical and cultural importance and the strength of its diplomacy and military. Egypt's roles in the League of Arab States, the Israeli-Palestinian Peace Process and the Nile Basin make the country a critical Middle Eastern and North African partner for the EU and its Member States. Egypt's parliamentary elections gave the Islamist parties a landslide victory — a two-thirds majority in the new People's Assembly. Some concerns have been raised over this majority and its commitment to safeguarding principles of democracy and pluralism in the new constitution, protecting human rights and preserving Egypt's international relations. The current human rights situation in Egypt is worrisome, in particular concerning the use of excessive force, the crackdown on civil society organisations and violence against women. The Egyptian economy is also in a desperate state, with foreign currency reserves down to an alarming level. If the current economic uncertainty continues, the country risks social unrest for some time to come. Egypt is a major trading partner for the EU. For many decades, the EU has been engaged in the political, social and economic development of the country via various programmes. Since the revolution, the EU's approach has not radically changed, and its assistance has increased only incrementally.
