Ireland's National Recovery and Resilience Plan: Latest state of play

Samenvatting Ireland's National Recovery and Resilience Plan (NRRP) is small compared with most Member States' plans. In absolute terms and per capita, it has the second smallest allocation (after Luxembourg) under the Recovery and Resilience Facility (RRF). Following the European Commission's update of national allocations, the initial €989 million allocation has been adjusted to €914.4 million in grants, to be disbursed in five instalments. Ireland has not yet submitted a REPowerEU chapter. It asked to amend its plan twice, in May and October 2023, cutting two measures and updating several others. Ireland requested its first payment in September 2023. Relative to the size of its economy, Ireland's RRF grants are not large: they are equivalent to around 0.3 % of the country's 2019 gross domestic product (GDP), while the total RRF amounts to 5.2 % of 2019 EU 27 GDP. Given also that spending will be spread over the years up to 2026, the RRF is not expected to have a significant direct impact on Ireland's key macroeconomic indicators. The European Commission estimates that it could increase Ireland's GDP by 0.3 or 0.5 % by 2026. A more significant indirect impact is expected from the overall boost to the EU economy and the associated cross-border spillover effects. The plan's overall objective is to contribute to a sustainable, equitable, green and digital recovery. It complements the government's broader domestic recovery efforts under the economic recovery plan, underpinned by the national development plan (NDP) of €165 billion, for 2021 to 2030. Although the RRF allocation amounts to less than 1 % of the total NDP investment, it will contribute to key reforms and investments. With 42 % of funding allocated for climate and 34.2 % for digital measures, the NRRP's 14 investment and 9 reform projects will also focus on strategic EU priorities. The European Parliament participates in interinstitutional forums for cooperation and discussion on the implementation of the RRF, and scrutinises the European Commission's work. Samenvatting The Protocol on Ireland/Northern Ireland forms an integral part of the 2020 EU-UK Withdrawal Agreement. It was designed to avoid the need for a hard border on the island of Ireland, and safeguard the all-island economy and the Good Friday/Belfast Agreement. Furthermore, the Protocol sets out to protect the integrity of the EU single market. Since the very beginning, implementation of the Protocol has been marred by rising tensions and political challenges, straining wider EU-UK relations. While the UK tabled various domestic legislative proposals seeking to over-ride parts of the Protocol, the EU responded with series of infringement procedures. The impasse appears to have been broken since Rishi Sunak became UK Prime Minister. The two parties entered into a fresh negotiation process, seeking to address the main problems. The new agreement, called the Windsor Framework, was announced in February 2023. It is designed to improve the trading rules for Northern Ireland, bring stability and clarity for businesses and people in the region, and open a new chapter in EU-UK relations. The framework is based on new data sharing agreements, novel arrangements for customs, agri-food, medicines, VAT and excise, and State aid, and new ways to engage the stakeholders and communities of Northern Ireland on the issues particularly important to them. The agreement was endorsed by the UK House of Commons and then by the EU-UK Joint Committee in March 2023. Despite the disapproval of some groups, the framework has been met with almost universal acclaim and appreciation. EU-UK relations could still deteriorate and new trade barriers emerge, however, if the latter deviates significantly from its current legislative model. While the framework constitutes an improvement in joint solution-finding and enhances mutual trust, it remains to be seen whether it really heralds the opening of a meaningful new chapter of closer relations with the UK.

Samenvatting This briefing gives a comparative assessment of initiatives being undertaken in RRF Pillar 4 across a sample of four National Recovery and Resilience Plans (NRRPs) in Ireland, Italy, Poland and Portugal. In each of them, it covers three measures falling into the categories territorial infrastructure, targeting of specific territories, and adult and vocational training. Pillar 4 is covered as a cross-cutting theme that is picked up across a range of components, but there is substantial variation in how each NRRP treats social and territorial cohesion. In all four cases, the NRRP sets out significant reforms and investments and there are spill-overs with other measures. The plans aim to ensure the sustainability of the supported measures via reforms, capacity-building and complementarities and synergies with other instruments, especially Cohesion Policy. Yet, there remain substantial strategic and operational challenges in achieving potential synergies and a risk of duplication and rivalry.

Samenvatting	As set out in Article 285 of the Treaty on the Functioning of the European Union (TFEU), the European Court of Auditors (ECA) shall consist of one national of each Member State. Article 286 (2) TFEU further specifies that each Member State has the right to propose its candidate. The Council then adopts the list of Members as proposed by the Member States. Often, this is a partial renewal of the Court - only one or a few Members are appointed, as the mandates of the Members may expire at different points in time. The Council can only act after consulting the European Parliament; in practice, the Committee on Budgetary Control (CONT) is responsible and the Member-designate of the ECA makes a statement before the committee and has to answer its questions. CONT then votes on the nomination and thus issues a recommendation to plenary, which votes within two months of receipt of the nomination. In case of an unfavourable opinion, the President shall ask the Council to withdraw its nomination and to submit a new nomination (Rule 129 of the EP's Rules of Procedure). However, Parliament's opinion is not binding for the Council.

Samenvatting	This year marks the 50th anniversary of the signing of the accession treaties to the former European Communities by Ireland and Denmark. The path to membership was not smooth for either country, with their first two applications made in 1961 and 1967, together with the United Kingdom, effectively blocked by French opposition. With a change of government in France, the six members of the European Communities reaffirmed their agreement to the enlargement of the Communities, and negotiations on membership began with Denmark, Ireland, Norway and the United Kingdom (UK). In Denmark, Ireland and Norway, referendums were held to decide on possible membership. The Danish and Irish people voted 'yes', while citizens in Norway narrowly rejected membership, with 53.5 % voting 'no'. On 1 January 1973, Denmark and Ireland (along with the UK) officially became members of the European Communities after more than a decade of negotiations. Over time, Treaty ratification referendums took place in other countries too, but were most concentrated in Ireland (7) and Denmark (4). In fact, Ireland remains unique in this sense as the only Member State that has held a referendum on every major Treaty revision since voting in 1972 to become a member. This was the first enlargement of the European Economic Community (EEC), bringing membership from the original six to nine members. It also meant that the number of Members of the European Parliament rose from 142 to 198, which represented an increase of nearly 40 %. This paper looks at the background to the decision to seek membership of the European Communities, examining the economic and political conditions that caused Ireland and Denmark to seek to become Member States. It also discusses key features of EU membership: for Ireland, the decision to join the euro and its relationship with the Schengen Agreement; and for Denmark, the opt-outs introduced with the advent of the Maastricht Treaty.

Samenvatting	The EU binding climate and energy legislation for 2030 requires Member States to adopt national energy and climate plans (NECPs) covering the period 2021 to 2030. In October 2020, the European Commission published an assessment for each NECP. Ireland submitted its NECP in mid-2019. A high proportion of Irish people (74%) expect national governments to tackle climate change. Ireland generates 1.7 % of the EU's total greenhouse gas (GHG) emissions and has reduced emissions at a slower pace than the EU average since 2005. With a low share of energy-intensive industry, Ireland's carbon intensity, relative to GDP, is among the lowest in the Union, with a higher than average decrease. Currently, the agricultural sector accounts for the majority of Ireland's emissions at 31 %, a 4.3 % increase since 2005. Whereas energy industries, manufacturing and industrial processes traditionally account for the majority of countries' emissions, in Ireland they account for only 28 % combined and have together reduced their emissions by 33 % since 2005. Ireland exceeded its allocations under EU effort-sharing legislation for 2020 and also for 2019 (by 15 %). Ireland intends to use effort sharing flexibilities to reach the 2030 target of a 30 % reduction relative to 2005. Ireland achieved a 12 % share of renewable energy sources (RES) in 2019. The country's 2030 target of a 34 % share is focused mainly on wind, with some solar and biomass, with a renewable energy (RE) in electricity target of 70 % by 2030. Energy efficiency measures centre on building stock, smart metering and support measures for low carbon heating and energy retrofits for industry and households. Samenvatting	On 9 September 2020, the United Kingdom (UK) government tabled a bill in the House of Commons which would govern the country's internal market after the Brexit transition period ends. It aims to allow goods and services to flow freely between the four jurisdictions of the UK – England, Scotland, Wales and Northern Ireland – replacing the rules now in place through membership of the EU's single market. Certain parts of this UK Internal Market Bill are particularly controversial, as they explicitly contravene the Protocol on Ireland/Northern Ireland attached to the Withdrawal Agreement (WA) that was ratified in January 2020. First, the bill provides that the UK government may authorise Northern Ireland businesses not to complete exit summary declarations when sending goods to Great Britain, thereby breaching the Union Customs Code applicable to NI. The bill would also allow the UK government to interpret, dis-apply or modify the application of the State aid rules of the European Union, which are applicable to UK measures that affect trade between Northern Ireland and the EU. Last but not least, the bill provides that UK regulations in these areas will have effect notwithstanding their incompatibility with relevant domestic or international law, including the Withdrawal Agreement. The reaction of the European Commission to the bill was immediate, calling for an extraordinary meeting of the EU-UK Joint Committee, which was held the following day, 10 September. On 1 October, the Commission sent a letter of formal notice to the UK for breaching its obligations under the WA, marking the beginning of an infringement process against the UK. As the UK did not reply by the end of October, the Commission may now proceed with the process, sending a Reasoned Opinion to the UK. Meanwhile, the bill has passed third reading in the House of Commons, even if in the House of Lords the government has been heavily defeated, with amendments removing the controversial clauses. While the government has indicated its intention to re-table the clauses when the bill returns to the Commons in December, it would be open to it to no longer press for their inclusion, if and when agreement is reached in the ongoing negotiations on the future EU-UK relationship.

Samenvatting	On 26 August 2020, Commissioner Phil Hogan tendered his resignation to the President of the European Commission following controversy over his participation in an Oireachtas (Irish Parliament) Golf Society dinner attended by more than 80 people, despite the applicable Irish public health guidelines adopted to contain the spread of Covid-19 limiting gatherings to a fraction of that number. In addition, questions were raised as to whether he had complied with applicable restrictions on movements after his arrival in Ireland. Although President Ursula von der Leyen had not formally requested his resignation, she accepted it and thanked Commissioner Hogan for 'his tireless and successful work' during the current mandate as Trade Commissioner and in his previous mandate as Agriculture and Rural Development Commissioner. Consequently, the procedure to replace him has started, with President von der Leyen requesting that the Irish government propose both a female and a male candidate. On 4 September, the Irish government proposed two candidates to replace Phil Hogan: Mairead McGuinness, current European Parliament First Vice-President, and Andrew McDowell, a recent European Investment Bank Vice-President. On 8 September, President von der Leyen announced she had chosen Mairead McGuinness, and that she would take over financial services, financial stability and the capital markets union from Valdis Dombrovskis. The latter would take the trade portfolio permanently (having already taken it temporarily in the meantime), while continuing in his role of Executive Vice-President. Parliament is now expected to organise hearings with both.

Finally, on Friday 8 December, an agreement in principle on the three priority issues – citizens' rights, a financial settlement and Northern Ireland – was reached. The European Commission President, Jean-Claude Juncker, and the UK Prime Minister, Theresa May, endorsed a joint report setting out a common understanding on the future withdrawal agreement. Whilst a number of specific aspects are still under discussion, the European Council decided on 15 December that 'sufficient progress' had been achieved on the first-phase priority issues, and that negotiations could move on to the second phase – on transitional arrangements and the future EU-UK relationship – provided the commitments from the joint report are fully translated into the draft withdrawal agreement. For the transitional period, the European Parliament and the European Council have made clear that all existing Union regulatory, budgetary, supervisory, judiciary and enforcement instruments and structures must apply, including the competence of the Court of Justice of the European Union, but with no UK participation in decision-making, since it would no longer be a member of the EU. Exploratory discussions on the framework for the future relationship will begin only after the adoption by the European Council of additional guidelines in March 2018. The UK has still to clarify its position on the type of trade deal it seeks with the EU.</p>

Samenvatting On 11 March 2015, Ireland's Regulation of Lobbying Act 2015 was signed into law by President Michael D. Higgins. The Act provides for, inter alia, the establishment of a mandatory register of lobbyists and lays out its rules. The Irish Lobby Register was only the sixth fully mandatory lobby register among the EU Member States, and attracted widespread attention due to its comprehensive scope. The drive to develop the legislation was strengthened by a number of public scandals in the country. The Irish Lobby Register presents an example which other Member States could follow, and might also be a source of inspiration for an EU system in transition. Its mandatory nature allows for a stricter approach, with investigations and sanctions available for non-compliance. Strict definitions enumerate those who fall under its scope, unlike the EU's all-encompassing activity-based definition of interest representation. While financial information is not requested of registrants under the Irish system, returns are required three times a year and provide greater detail on all instances of lobbying activity carried out. Its scope is both broad and ambitious. As with any new legislation, the effectiveness of the new Irish system can only be measured in practice. The register has met with a positive start, registering a high uptake. A critical period is approaching, with the legislation to be reviewed in September 2016, one year after its commencement. The powers of investigation and sanctions under the Act will also come into force simultaneously.

Samenvatting The study was requested by the European Parliament's Committee on Women's Rights and Gender Equality and commissioned, overseen and published by the Policy Department for Citizens' Rights and Constitutional Affairs. This assessment aims at investigating gender differences across EGF interventions. By adopting gender budgeting principles, the analysis shows that there are at least four factors resulting in different treatment of men and women in the implementation of the fund: a more frequent implementation of the EGF in male-dominated sectors based on the fact that the impact of the crisis by sectors is not gender neutral, the size of the firms involved in the interventions, and the prevailing productive structure by sectors. Apart from a general analysis, the study includes also detailed analyses of EGF cases in seven Member States.

Samenvatting From 2007 a series of crises in the economic and financial sphere hit the European Union. These were partly linked and tended to amplify each other. Two of the hardest hitting, the financial and sovereign debt crises, were closely intertwined and put immense pressure on the euro area, stressing the financial sector and pushing Member State governments' budgets to their very limits. Several Member States lost access to the capital markets, and required financial assistance from both the euro area and the IMF. Unlike the United States economy, the euro area economy has failed to bounce back from the economic crisis owing to its ongoing sovereign debt crisis. Although the initial shock of the financial crisis came from the United States of America, the crisis took a different twist in the euro area, which was not prepared for such an event. There were no proper crisis resolution mechanisms in place, nor were there sufficient budgetary margins available to save the banks and reinvigorate the economy without putting the sustainability of public finances in jeopardy. The Stability and Growth Pact, a central element of Economic and Monetary Union, had failed to produce the necessary fiscal margin. Problems were compounded by macroeconomic imbalances that had built up inside several Member States. The European Union fought on two parallel fronts: saving banks and supporting stressed sovereigns in order to extinguish the fire, while also correcting the framework with the aim of avoiding a recurrence of similar crises. Although the worst seems to be over, problems persist and a renewed flare-up is not impossible.

Samenvatting	On 9 December 2015, the Commission tabled a proposal for a directive on contracts for supply of digital content to consumers. The proposal would cover, with a single set of rules, contracts for the sale of digital content (e.g. when consumers buy music, films, e-books or applications), for rental of digital content (e.g. when consumers watch a movie online, but do not download a copy), as well as contracts for digital services, such as cloud computing and social media. The proposal envisages a maximum level of harmonisation, meaning that it will be prohibited for Member States to enact or retain more consumer-friendly rules within the directive's scope. Currently, only the UK has enacted rules designed specifically for contracts for supply of digital content. A similar legislative bill was recently discussed in Ireland. Other Member States, such as Germany and the Netherlands, have extended the scope of existing contract rules, especially on consumer sales, to include sale of digital content. Yet in other Member States, such as Poland, there are no explicit rules on supply of digital content, which leads to legal uncertainty and practical difficulties regarding the rights and remedies available to consumers in case of non-conformity.

Samenvatting	Since 2010, the ECB – in particular as a component of the so-called Troika - has been providing technical assistance/advice in the design and adoption of measures for contributing to the financial stability of crisis-hit countries. The ECB's role has been especially - but not exclusively - important in decisions concerning the recapitalization of national financial systems. Actions taken by the ECB in that context have been sometimes criticized as undemocratic and questioned for granting an excessive power to the institution and interfering with Member States' national sovereignty. The notes in this compilation by key monetary experts discuss the pros and cons of these ECB actions in the light of ECB mandate and its institutional dimension. In particular, the note discuss whether similar actions put ECB independence at risk. Samenvatting	This Study examines the functioning of EU Justice and Home Affairs (JHA) cooperation in light of the reforms and innovations introduced by the Lisbon Treaty since the end of 2009. It identifies the main challenges and deficits characterising the practical and effective implementation of these transformations and suggests specific ways for the European Parliament to address them. The Study recommends that that any future legislative reform or Treaty change should not promote or enable further differentiation in the next generations of EU AFSJ cooperation. Samenvatting	EU Social and Labour Rights have developed incrementally, originally through a set of legislative initiatives creating selective employment rights, followed by a non-binding Charter of Social Rights. Only in 2009, social and labour rights became legally binding through the Charter of Fundamental Rights for the European Union (CFREU). By contrast, the EU Internal Market - an area without frontiers where goods, persons, services and capital can circulate freely – has been enshrined in legally enforceable Treaty provisions from 1958. These comprise the economic freedoms guaranteeing said free circulation and a system ensuring that competition is not distorted within the Internal Market (Protocol 27 to the Treaty of Lisbon). Tensions between Internal Market law and social and labour rights have been observed in analyses of EU case law and legislation. This report, provided by Policy Department A to the Committee on Employment and Social Affairs, explores responses by socio-economic and political actors at national and EU levels to such tensions. On the basis of the current Treaties and the CFREU, the constitutionally conditioned Internal Market emerges as a way to overcome the perception that social and labour rights limit Internal Market law. On this basis, alternative responses to perceived tensions are proposed, focused on posting of workers, furthering fair employment conditions through public procurement and enabling effective collective bargaining and industrial action in the Internal Market.

Samenvatting The right to vote is a fundamental one and of utmost importance for the democratic legitimacy of any public power. Six EU Member States deprive their nationals permanently resident abroad of the right to vote in national parliamentary elections. They also deprive such citizens residing in a third country of the vote in European elections, and two of them even when their nationals live in another EU Member State.

Citizens disenfranchised in their country of origin often face exclusion from political life at national level in both their country of origin and of residence. In the case of citizens living in another EU Member State, the disenfranchise rules could even amount to an infringement of their freedom of movement and residence under EU law.

Solutions discussed include a Treaty change to allow EU citizens to vote in national parliamentary elections in their host Member State or to be able to choose between voting there or in their Member State of nationality. A more realistic solution envisages the abolition of disenfranchise rules in those six Member States concerned, although such calls from EU institutions have found very limited favour in the six concerned.

It finds that there are no overall quantitative shortages at EU-28 level in the wake of the economic crisis, but qualitative shortages, especially relating to skills shortages and mismatch, occur in several regions, sectors, occupations and Member States. Employers and Member States are the prime actors to counter labour shortages effectively, but the EU can play an important supporting role through its influence on intra-EU mobility, by increasing the transparency of the labour market and by using its structural funds as supportive frameworks.

Samenvatting The right to vote in elections is a fundamental right common to the constitutional traditions of the Member States, and recognised in the EU Treaties as intrinsically related to the right of political participation which, for its part, provides democratic legitimacy to those exercising public power. This right is not absolute though and is subject to restrictions. The decision of who is conferred the right to vote in national and also in European elections lies with states.

Six EU Member States deprive their nationals, under varying conditions, of the right to vote in national parliamentary elections due to residence abroad, both in other Member States and in third countries. These same six Member States also disenfranchise their nationals in European elections, if they live permanently in a third country, and two of them even do so in respect of nationals resident within the EU.

'Disenfranchisement' due to residence abroad can be a result of minimum residence requirements in the country in which elections take place as well as of losing electoral rights due to time spent abroad. The lack of facilities to vote from abroad, while rendering the exercise of voting rights difficult, does not amount to their loss as such. Disenfranchisement is based on the assumption that expatriates are not affected by the political decisions taken in their country of nationality and that they are not able to cast a meaningful vote due to lack of knowledge of the political reality there. Globalisation and improved communication means have however induced a tendency towards enfranchising expatriates.

Citizens deprived of their right to vote in national elections in their country of nationality often face exclusion from political life at national level in both their state of residence and their state of origin since EU Member States (and more so third countries) do not generally provide any right to vote in national elections to non-nationals. Whilst the European Court of Human Rights saw no infringement of Convention rights from disenfranchisement rules, the loss of electoral rights for citizens who move to another EU Member State could be seen as an infringement upon the freedom of movement under EU law, since it could potentially stop EU citizens from exercising their free movement rights.

Different solutions have been discussed. Actions at EU level include a possible infringement procedure against those Member States who disenfranchise their nationals resident elsewhere in the EU, as well as a Treaty change to include a voting right for EU citizens in their host Member State or the right to choose to vote in national elections either in their Member State of nationality or in the host Member State. Another proposal, which is more realistic in the short term, is to convince Member States to enfranchise nationals living in another EU Member State or at least to enhance the conditions for them to preserve their right to vote.

Samenvatting Two of the four macroeconomic adjustment programmes, Portugal and Ireland's, can be considered a success in the sense that the initial expectations in terms of adjustment, both fiscal and external, were broadly fulfilled. A rebound based on exports has taken hold in these two countries, but a full recovery will take years. In Greece the initial plans were insufficient. While the strong impact of the fiscal adjustment on demand could have been partially anticipated at the time, the resistance to structural reforms was more surprising and remains difficult to cure. In Cyprus, the outcome has so far been less severe than initially feared. It is still too early to find robust evidence in any country that the programmes have increased the long-term growth potential. Survey-based evidence suggests that structural reforms have not yet taken hold. The EU-led macroeconomic adjustment programmes outside the euro area (e.g. Latvia) seem to have been much stricter, but the adjustment was quicker and followed by a stronger rebound.

Samenvatting This study provides a systematic evaluation of financial assistance for Greece, Ireland, Portugal and Cyprus. All four programmes, and in particular the Greek one, are very large financially compared to previous international programmes because macroeconomic imbalances and the loss of price competitiveness that accumulated prior to the programmes were exceptional. Yet programmes were based on far too optimistic assumptions about adjustment and recovery in Greece and Portugal. In all four countries, unemployment increased much more significantly than expected. Although fiscal targets were broadly respected, debt-to-GDP ratios ballooned in excess of expectations due to sharp GDP contraction. The GDP deterioration was due to four factors: larger-than-expected fiscal multipliers, a poorer external environment, including an open discussion about euro area break-up, an underestimation of the initial challenge and the weakness of administrative systems and of political ownership. The focus of surveillance of conditionality evolved from fiscal consolidation to growth-enhancing structural measures. The Greek programme is the least successful one. Ireland successfully ended the programme in December 2013, but problems remain in the banking system. Exit from the Portuguese programme in May 2014 appears feasible but it should be accompanied by a precautionary credit line. It is too early to make pronouncements on the Cypriot programme, which only started in May 2013, but it can safely be said that there have been major collective failures of both national and EU institutions in the run-up of the programme.
